BUYER-SELLER CONTRACT AGREEMENT

I, Karen K. Lovett, Woodson Ridge Danes™, of 613 CR 215, Abbeville, MS 38601 and telephone number being (662)816-9114, hereinafter referred to as SELLER and _____, hereinafter referred to as BUYER(s) agrees to the following terms and conditions with respect to the Great Dane puppy(s)/dog(s) whelped on _____, ___/20___, with color being _____, sex _____.

Sire of said litter is AKC registered as _____, with AKC registration number being _____, and call name "_____".
Dam of said litter is AKC registered as _____, with AKC registration number being _____, and call name "_____".

The litter registration number on this puppy is _____. The full purchase price of this puppy (dog) is \$_____. Any shipping charges, crates, etc., are additional to the purchase price of the puppy (dog). This puppy is being sold with full/limited registration. Seller states that the puppy is guaranteed healthy at the time of purchase, has been checked for worms, and, if required, has been wormed in accordance with the veterinarian's instructions. The seller further states that the puppy will have had first puppy shots at 6, 9, 12, and 15 weeks of age, if the pup is still in his/her possession at that time.

Buyer is advised to keep puppy isolated from other animals until series of shots is completed in order to avoid contagious diseases. Seller guarantees that socialization has been done in accordance with the age of the puppy that he/she has been introduced to adults, children, and other animals. Buyer agrees to provide space in a safe and proper area that is adequate for the breed. Buyer agrees that the puppy is to be protected from extreme cold or heat and dangerous encounters that may jeopardize the welfare of the puppy/dog. The Buyer understands and agrees that the puppy needs all of the appropriate inoculations at intervals suggested by Buyer's veterinarian. The puppy should be placed on heart-worm preventive as deemed appropriate by your veterinarian.

It is recommended that the Buyer not breed this puppy, if a female, until after the puppy's second year, and then only breed this puppy (male or female) to a dog whose standards are equal to or better than his dog in order to upgrade this breed. Buyer also agrees that he will not sell any puppies that result from this puppy/dog to pet shops or pet brokers.

In the event the Buyer finds that they are unable to keep this puppy/dog for any reason, Buyer agrees to contact Seller in order that Seller may help find a suitable home for the puppy/dog. This will insure that the puppy/dog will always be wanted and not end up in a shelter.

Buyer agrees to have this puppy health checked by a licensed veterinarian within 72 hours of receiving the puppy. Should the veterinarian find that this pup has a serious disease or congenial defect and a written statement is provided by the examining veterinarian, then the puppy will be replaced or a refund of the purchase price of the puppy will be given. This policy will apply only if the original owners are still in the care and possession of the pup and the pup is seen by a licensed veterinarian within those 72 hours.

The bill of sale and the proper papers for registration will be presented to Buyer(s) when puppy is paid for in full and delivered. The Seller agrees that in the event that genetic life-impairing defect is diagnosed by (2) veterinarians within the first 6 months of a puppy's life, said animal will be given another of equal value, when available. Copies of all verifying tests made to diagnose must also be presented to Seller and be reviewed by Seller's veterinarian. Buyer may choose to keep the puppy/dog; however, proof of spay/neuter of the puppy/dog, in order to prevent producing inferior pups from this puppy/dog, must be presented to Buyer before puppy/dog will be replaced.

I, the Buyer, have read and understand the terms of this guarantee/agreement. It is further understood and agreed that no warranty or representation has been made with respect to sold puppy/dog except as set forth in this document.
